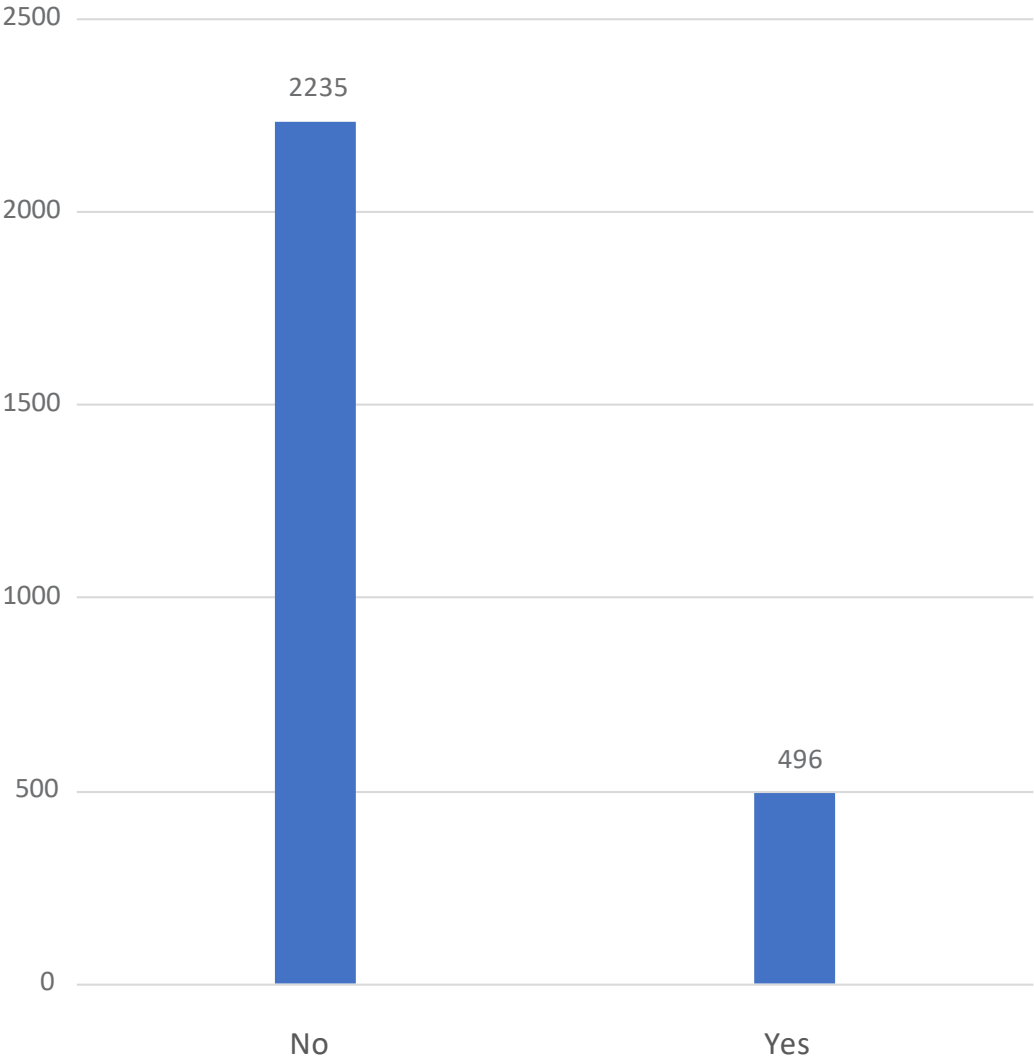

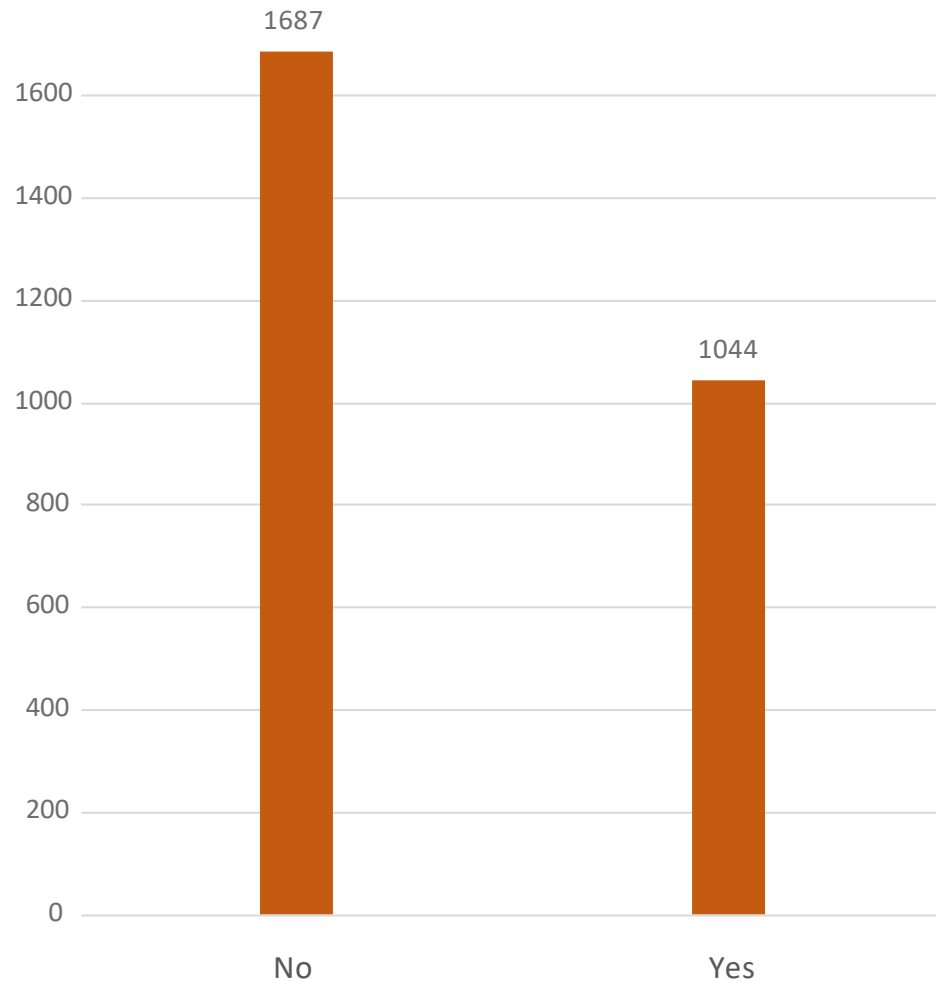
OVER 50% HAVE BEEN RELEASED FROM SUPERVISION

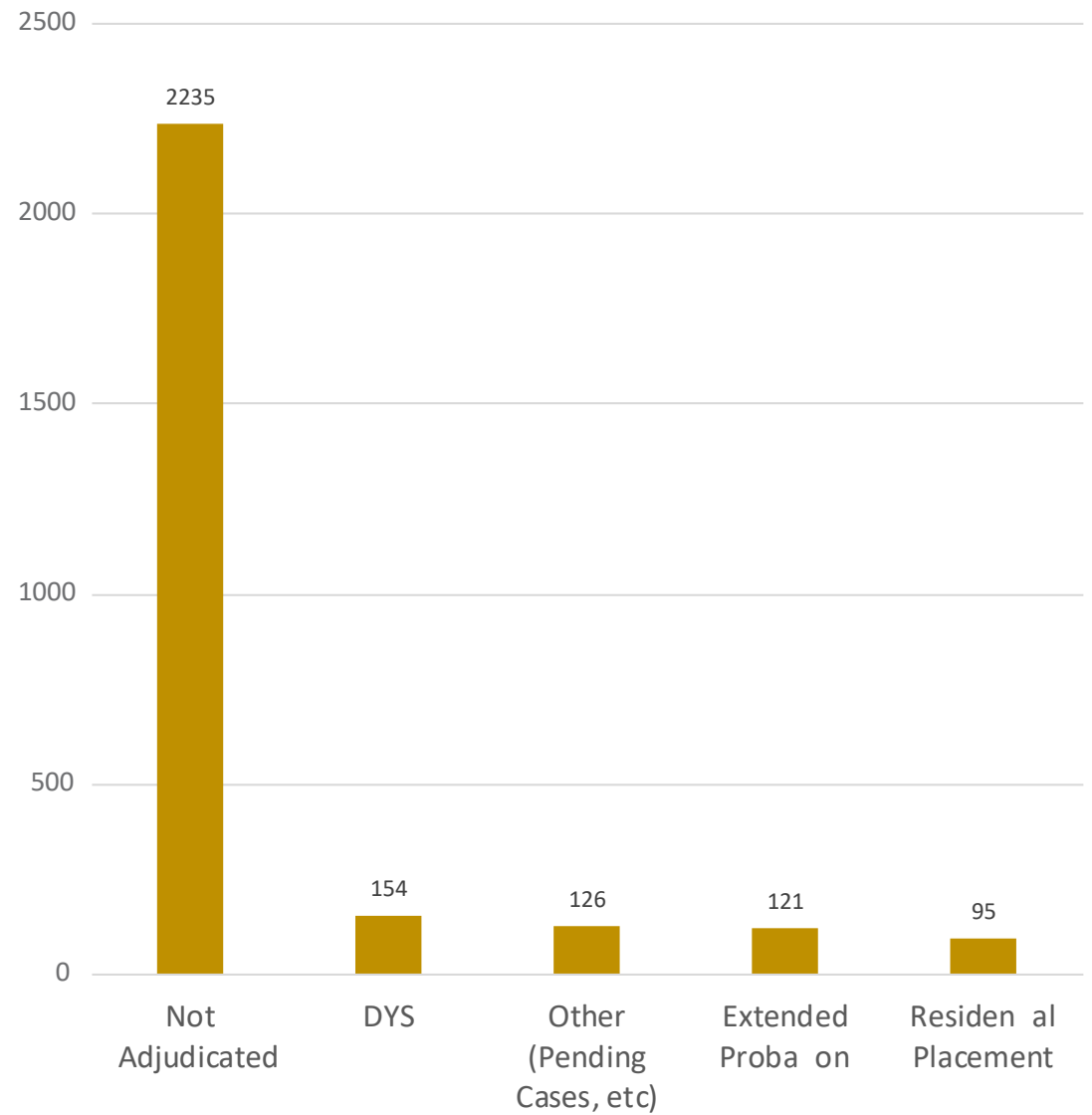

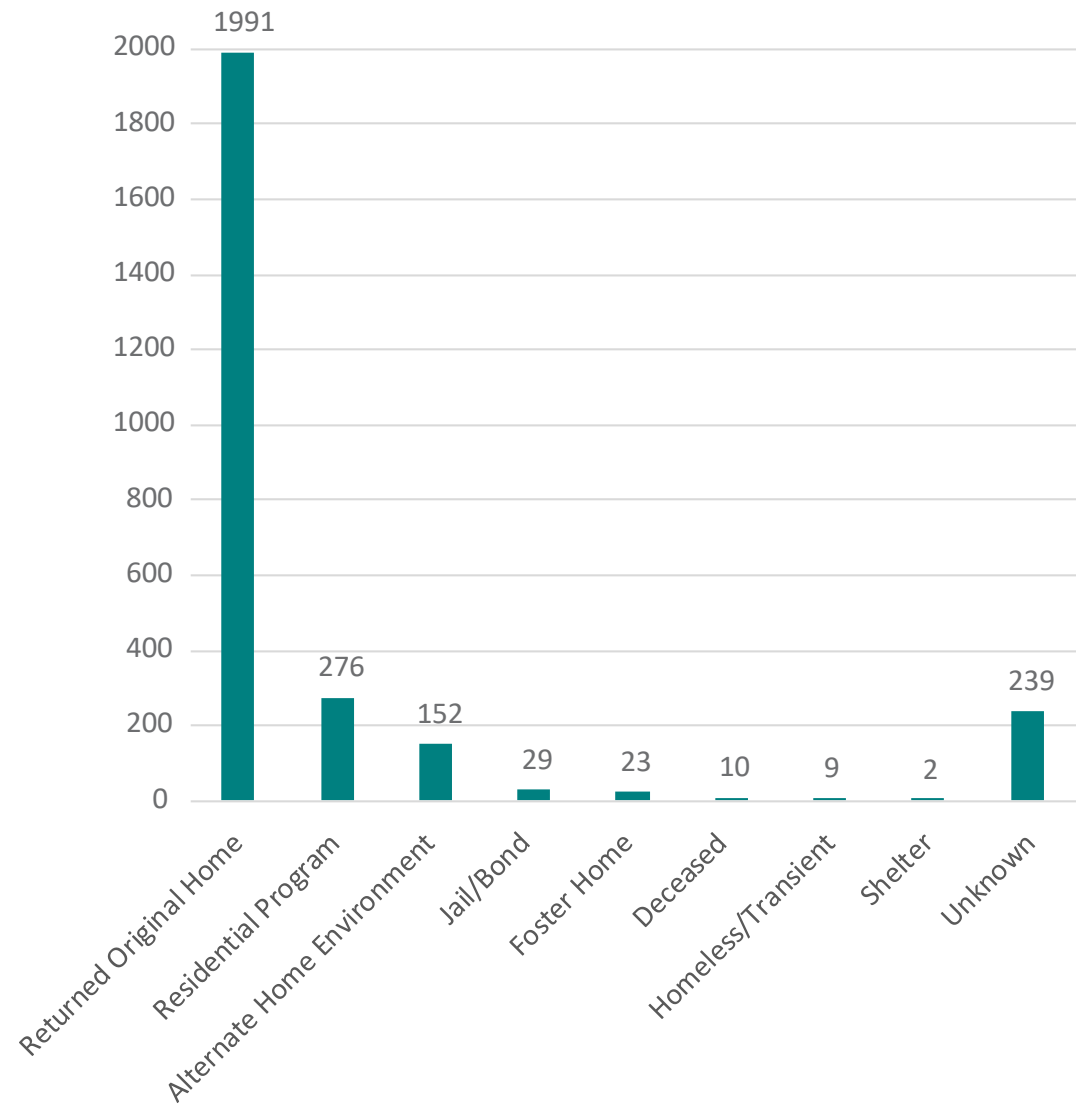
73% ARE STILL LIVING AT HOME

Our interest in Destination was to determine where the youth was living at the time of follow-up. We wondered if the child had continued living in their home or if other arrangements had become necessary at the 6-month interval.

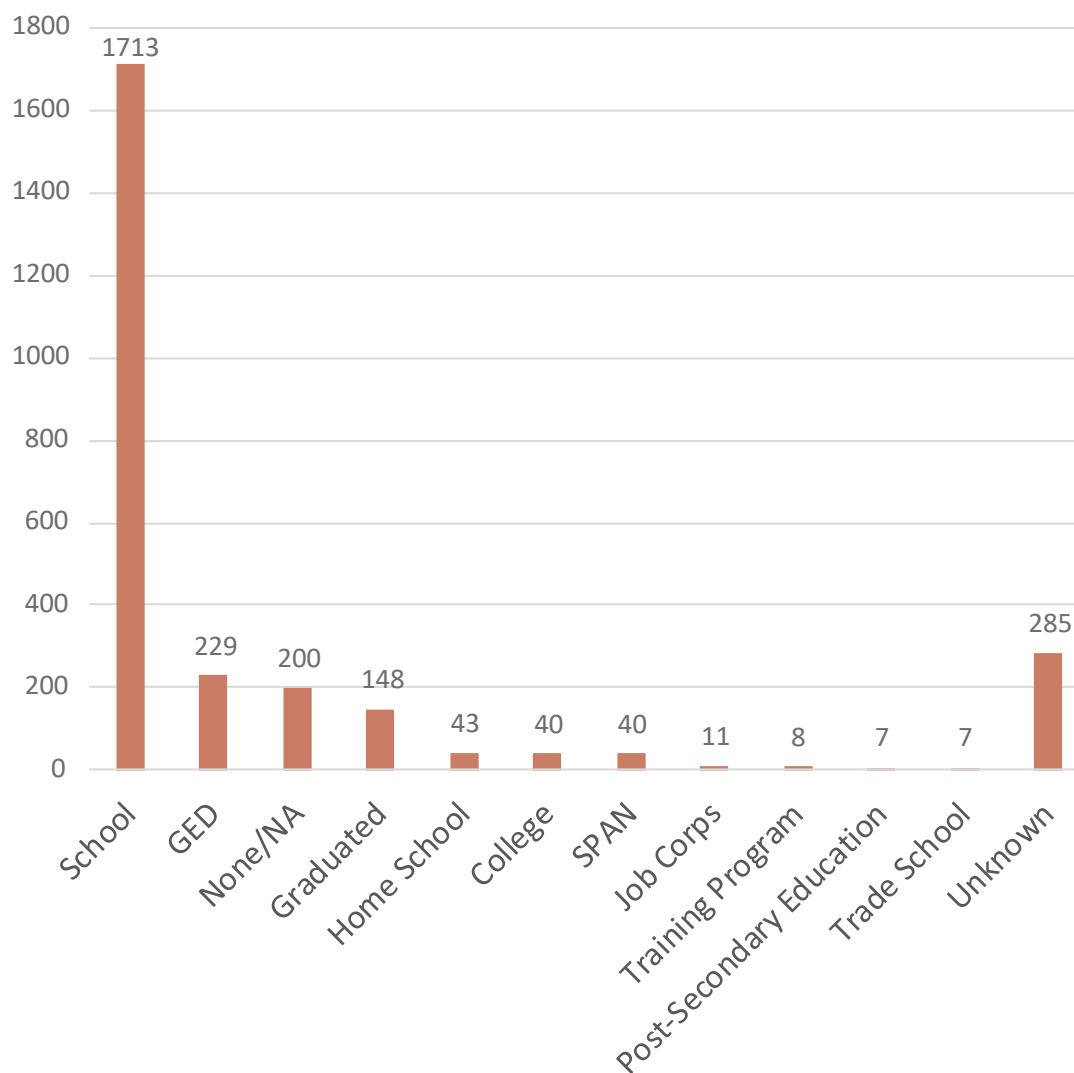
DIVERSION PROGRAM YOUTH STAY IN SCHOOL

Our population is mainly school aged and we wanted to gauge where in the educational system our youth had landed in the 6 months after they were involved in the Diversion Program. The "None/NA" response refers to youth that are no longer in school.

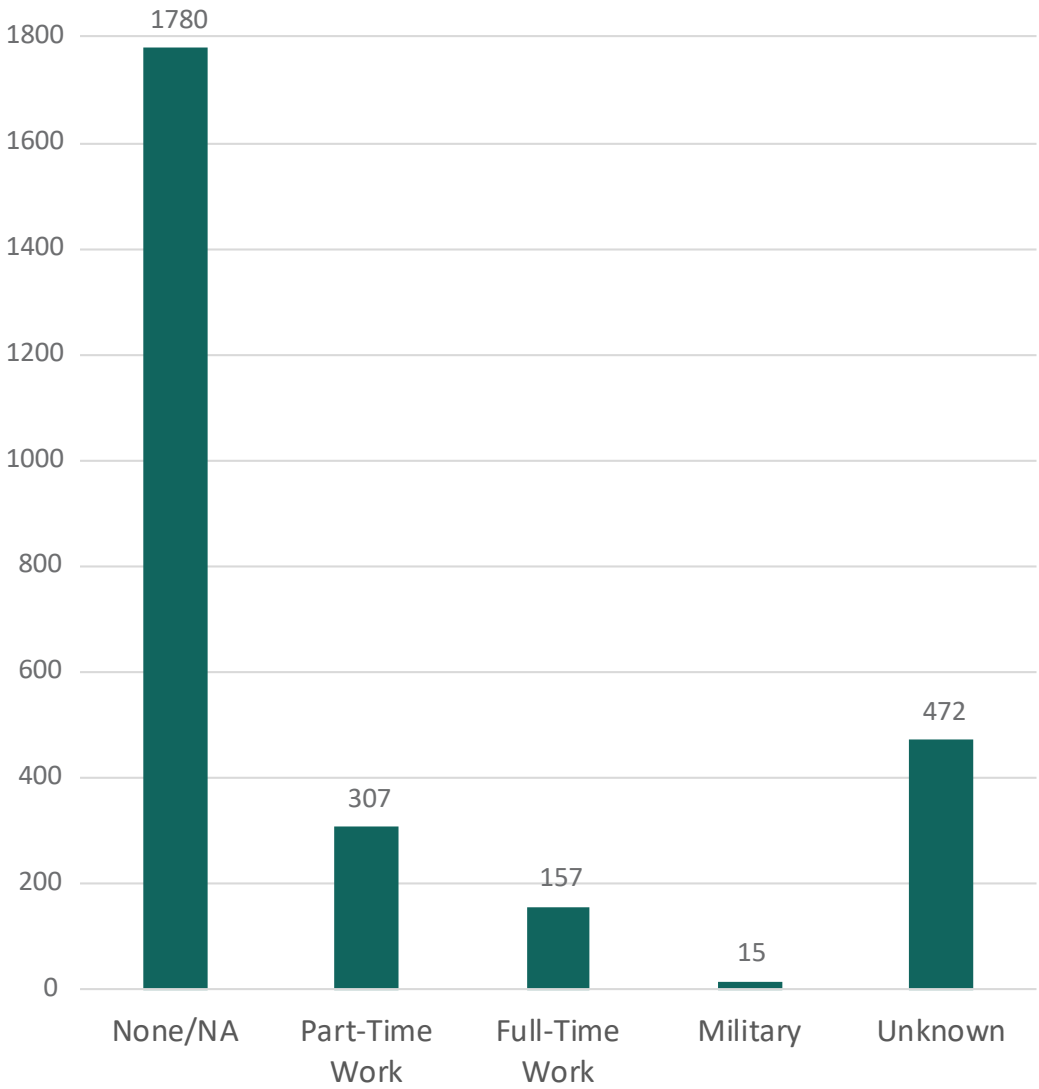
20% ARE IN SOME TYPE OF EMPLOYMENT

Employment

Although education is usually the priority at the age of these participants, employment experience is an important measure of progress. As expected the vast majority were not employed but the data suggests nearly 20% of the youth were engaged in some type of employment at the 6 month interval.
