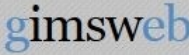

2. In closing out a juvenile, a new outcome option has been added:

Neutral/Assessment

This option does not count as either a successful or unsuccessful outcome but indicates that the juvenile has been absent from the program for 21 days or more. The juvenile should remain in the program during absences of 21 days or less. If you use this option, this requires that the juvenile would need to begin the program with a new record upon his return. Options for Neutral/Assessment completion include moving from the county, drug treatment program, mental health treatment, detention, and inappropriate for the program.

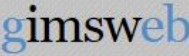

Follow-up Outcomes:

A new screen has been added for recording information about outcomes for juveniles six months after they've completed the program. 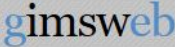
